For decorations/drapery, a CA State Fire Marshal flame certificate must accompany any fabrics or decorations that will be hung from walls, ceilings, or pipe. If you have any additional information, please attach it to this application. Permit payment will be made after approval and can be done so online or in person before issuance.
